## Reports:

- 1. Joel Berman reported that Pam Crawford will represent the Florida Section at MathFest in August 2008.
- 2. John Waters reported that our balance as of 2/15/08 was \$12,885.99 and that all of our annual financial reports are currently in preparation to send to national later in the month. John proposed that we adopt a policy by which

student speakers could choose either an MAA book from the section's collection or a one-year membership in the MAA.

- 3. Scott Hochwald reported that a power point presentation entitled the 'National Report from the MAA' would be posted on our website. Although, this presentation covers events of 2007 it still contains pertinent information. Scott reported that his 'Governor's Session' at the Florida Southern meeting went well and that we should incorporate this session into future meetings.
- 4. Chuck Lindsey distributed a template of reports he needs for the May 2008 newsletter President's report, Governor's report, etc. He also said that he would coordinate with the national MAA on updating our list of 'Institutional Liaisons.'
- 5. Bettina Capuano reported that Embry-Riddle will host the 2010 meeting and that both Santa Fe Community College and Valencia Community College East Campus are possible sites for the 2011 meeting.
- 6. Julie Francavilla reported that she would like to continue the integral and sudoku contests at the 2009 meeting and is considering adding a Kakuro contest and possibly a session of 'Math Jeopardy.'
- 7. Pam Crawford gave the President-elect report and indicated that 3 regions of the Florida Section met this past year. There were First Coast with Scott Hochwald as the plenary speaker, West Coast and Suncoast with Jerry Junevicus as the plenary speaker.
- 8. Chuck Lindsey requested that the 2009 meeting be moved to February 13 and 14 as opposed to the originally scheduled February 20/21 because of planned events on the FGCU campus. The Executive Committee formally approved the request.
- 9. Don Ransford reported that Bill Hemme from St. Petersburg College is FTYCMA's Vice-president for Programs. Don reported that the FTYCMA Fall Retreat would be on October 3 and 4 at the SPC Tarpon Springs campus. Topics of the retreat would include college-readiness and assessment of secondary math education programs.

10. Scott Hochwald reported that the section has been asked to prepare a 'section history' for the MAA's centennial celebration. David Kerr said that he would ask Fred Zerla if he would not mind formulating the initial draft.
