
MAA Iowa Section Governor's Report

Membership




Membership increased substantially from 2014 to 2015, primarily due to changes in the Departmental Membership, which now allows departments to offer membership to all of their math students. This is the first time membership has grown year over year since 2004. (Over the previous 10 years, the MAA lost, on average, 7.7% of its members each year.) Core membership (members paying at or near full membership dues) also rose from 2014-15, and continue to track higher in 2016. On the other hand, at least 40% of our non-student members are over 60. On the other side, we seem to be only adding 100 members per year of tenure-track faculty and many of these only join when they are going to attend a national meeting. This is not a specifically MAA problem in that most associations are having convincing this generation to join.

Finances

There is good news and bad news about the Financial situation of the MAA as a whole. On one hand, the association has Total Cumulative Net Assets of about \$13.4 million. On the other hand, in 2015, the MAA suffered its eleventh consecutive year of annual operating deficits, with a 2015 deficit about double what was budgeted. Starting in 2005, we had three years of annual deficits averaging about \$31,000 and then seven years averaging about \$211,000; the deficits for 2015, 2016, and 2017 are averaging close to \$1,000,000.



Articles of Incorporation and Bylaws

The MAA Articles of Incorporation and Bylaws are being updated for the first time in 100 years to comply with current state (Illinois) and federal laws. You can read all about it at

At MathFest, the Board of Governors was asked to vote to approve the changes. I seem to have voted in favor of moving myself out of the job of Section Governor and into the job of Section Representative to the MAA Congress if the Bylaws pass at the Joint Math Meetings in January 2017.

Specifically, what I consider the most important changes are:

- 1. Article V, Section 2 was modified to create a small Board of Directors consisting of the set of Officers. Section 7 was modified but continues to provide the Voting Membership a direct mechanism to voice concerns to the Board of Directors.
- 2. Article VI creates a new representative Congress which advises the Board of Directors on several matters and elects three members of the Board of Directors. This includes the authority to set strategic goals for the Association and to foster communication among the various constituencies within the Association.
- 3. Article VII was modified to be in alignment with the Illinois General Not-for-Profit Corporation Act of 1986 (the Act). The Board of Directors makes appointments to committees, not the president. There are two types of committees: Board committees, whose membership must have a majority consisting of Board members and which can act on behalf of the Board, and

Advisory committees whose membership can be open but which can only advise the Board. (Mathematical Association of America, 2016)
