1. Call to Order

The meeting was called to order at 9:13 am by Section Chair Diamantopoulos.

2. Attendance

A quorum of greater than 20 members of the section was established by electronic means.

3. Financial Reports

A. Treasurer's Report – Kristi Karber

The report was presented by Section Treasurer Kristin Karber. Due to the cancellation of the 2020 meeting, Treasurer Karber summarized the Section's financial statements for two years.

Treasurer Karber noted the low numbers of income and expenses in the 2020 report are due to the cancellation of the 2020 Section Meeting.

Nicholas Jacob moved to accept the treasurer's report as given, seconded by Sarah Marsh. The report was approved unanimously.

B. Audit Report

The audit was completed by Amy Schachle, the preceding Past Chair of the Section. The audit report was delivered by Secretary Rigsby. No errors were found in the financial reports.

4. Approval of 2019 Business Meeting Minutes

The minutes for the 2019 General Business Meeting recorded by Secretary Rigsby were made available for review by posting on the section website and though a link to a folder shared with meeting participants. A motion to accept the minutes as written was made by Nicholas Zoller and

seconded. The minutes were approved.

5. Elections

A. Discussion of Process of Selecting Officers for 2020 – 2021

Secretary Myron Rigsby informed the section about the process of filling open positions in the executive committee in the absence of elections during a Section Business Meeting in 2020. Article III, Section 6 of the Section by-laws states, "If a vacancy should occur on the Executive Committee (other than the Section Governor's position), the remaining members of the Committee shall appoint a member of the Section to serve until the next annual business meeting of the Section". Accordingly, the Executive Committee unanimously appointed

- Myron Rigsby, whose term as Secretary ended in 2020, to serve one year as Section Secretary, with an election to be held for the remaining two years of the term at the 2021 general business meeting.
- John Diamantopoulos to continue serve as the Section Chair for 2020-2021 after Mark Johnson, the previous 1st vice chair, declined to fill the position.
- Jeanine Myers to continue to serve as Section Past-Chair as 2019-2020 Chair Diamantopoulos continues as Chair.
- Carolyn Eoff to serve as 2nd Vice Chair as the representative of the 2022 host institution.
- As there was no Court Lecture for this meeting, the open Court Lecture Committee membership was left vacant.

No concerns with the process were raised from the floor.

B. Presentation of ballot from Nominating Committee

Lakeshia Legette Jones presented the nominations from the Section Nominating Committee and presided over the elections. Votes were cast and counted by electronic means during the meeting. No additional nominations were made from the floor. The following officers were elected:

6. Officer Reports

A. Section Representative

Section Representative Britney Hopkins informed the membership on MAA initiatives, member benefits, and opportunities for involvement. Among the items noted by Representative Hopkins were

- MathFest will be virtual, August 4-7, 2021. National meetings of MAA groups will now be help at MathFest rather than JMM.
- New memberships available:
 - o Transitional, for graduate students moingin int full-time employment.
 - o VITAL, for teaching assistants and temporary instructors.
- Opportunities for involvement, including Committees and SIGMAs.
 - o Include opportunities for discussion and action on issues of access and inclusion.

B. First Vice Chair

First Vice Chair Narayan Thapa recognized the faculty and staff of Cameron University for their contributions to making a successful virtual meeting possible. First Vice Chair Thapa reported a total of 153 registrations for the meeting. The following is the break-down by type of registrant:

C. Communications Director – Michael Lloyd

Communications Director Michael Lloyd reported that nine department chairs submitted information for the newsletter. Communications Director Lloyd thanked the section membership and officers for their contributions to the website and newsletter and thanked the section for allowing him to serve as Newsletter Editor from 2006-2013 and Communications Director from 2013-2021.

D. Secretary

Secretary Myron Rigsby reported there were 13 oral presentations by undergraduate students and 33 by faculty and graduate students. While the number of uindergraduate presentations was significantly less than in recent in-person section meetings, the number of presentations by faculty and graduate students were only slightly reduces compared to recent years. Secretary Rigsby also encouraged the membership to join MAA *Connect* and sign up for communications from the section, as this is the most effective way for the officers to communicate information to the section membership.

7. Committee Reports

- a. Department Chairs' Committee Michael Lloyd
 - Michael Lloyd presented the report on behalf of Carolyn Eoff. Discussion centered on three topics: i) diversity, equity, and inclusion of underrepresents groups in mathematics departments, ii) the future of online instruction, and iii) the growing use of a co-requisite model to accomplish remediation during the completion of college level courses.
- b. Sponsors of Student Chapters Chizuko Iwaki
 Chizuko Iwaki reported the major topic of conversation was discussion of the challenges
 of keeping the student groups active during the pandemic, and sharing of ideas to keep
 students engaged.

c. Resolutions Committee (Secretary) – Myron Rigsby
Before presenting the resolutions, Secretary Rigsby made special mention of several key
contributors in the work associated with managing the section through a difficult period

for agreeing the continue in the past-chair role for an additional year. Secretary Rigsby
also made special mention of two persons completing their service after multiple terms in
their current positions, Chair John Diamantopoulos and Communications Director
Michael Lloyd. Secretary Rigsby also thanked the membership for their support and

Other topics discussed including the sharing ideas for facing challenges of teaching during the pandemic. the group joined the faculty workshop on Saturday morning on "Teaching Mathematics via Primary Historical Sources" led by Dominic Klyve.

e. Site Selection Committee – Sarah Marsh

f. Student Competition Committee – Scott McClendon

Committee Chair Scott McClendon thanked the membership of the committee and the site proctors for their innovative assistance in making the on-line competition possible. Chair McClendon also acknowledged the assistance of Cengage Publishing, particularly their representative Philip Harp, for their assistance in the use of the WebAssign platform for offer the integration bee, and the special assistance of Chris Sauer for integrating the competition with Zoom. Ten teams competed in Math Jeopardy, and 21 students participated in the integration bee. Congratulations to the winners, listed in the *Resolutions*

g. Student Contributed Talks Committee – Kristi Karber Committee Chair Karber reported there were 13 presentations by students. Chair Karber gave special thanks to the judges and announced the recipient of the Deal Award and the other top presentations. The names of the recognized student presenters are recorded in the *Resolutions*.

8. Other Business

a. Upcoming Revision of Section By-Laws – Myron Rigsby

Secretary Rigsby informed the membership about the schedule of the up-coming revision of the Section By-Laws required by MAA. Our revision cycle is scheduled for the 2022-2023 cycle. A draft of the revised by-laws must be submitted to the Committee on Sections by December 1, 2022. After review and feedback for the Committee on Sections, the final draft will be voted on by the Section at the 2023 Section Meeting and submitted for approval to the Board of Governors.

Therefore, any significant revisions to the by-laws will need to be discussed and voted on at the 2022 Section Meeting.

b. Future of Named Lecture Program.

Secretary Rigsby updated the membership on the history and recent decisions affecting the N. A. Court and R. B. Deal Lecture Series. These lectures (travel and honaria) are funded through family bequests to the Section. As these funds have dwindled, the Section has moved to a model of two lectures per meeting, alternating a Court and Deal Lecture in years when the Section did not qualify for a Polya or Editor Lecture in addition to the Section Visitor. This has created questions regarding the separate

committees for selecting the two lecturers. With MAA announcing the above-mentioned new lecture series that will provide two visitors to the section each year, decisions need to be made regarding the future of the lectures.

Secretary Rigsby proposed the following motion:

The Section requests the Court Lecture Committee to work with the Section Treasurer to draft a plan for the future of the two traditional named endowed lectures, the *N. A. Court Lecture* and the *R. B. Deal Lecture*. This plan will include a financially sustainable schedule for these lectures in future Section Meetings, and a proposal for the selection of a committee to select future speakers.

The Court Committee will report this plan at the 2022 Section Business Meeting for consideration by the Section membership.

The motion was seconded and passed unanimously.

c. Term and Method of Selection of Section Chair.

Responding to a suggestion from a member of the Section, the Executive Committee has discussed the possibility of electing the Section Chair to a three-year term, elected by the membership. This would separate the selection of the Section Chair form the selection of a host institution. Discussion from the floor centered on advantages and disadvantages, and the effect of the change on the rotation and selection process for the First and Second Vice Chair and Past-Chair positions. Following discussion, volunteers were invited for a committee to study the issue and make a recommendation to the Executive Committee to review. The Executive Committee will present a final proposal of changes, if any, to the Section Membership for a decision on inclusion in the by-laws revision.

d. Issues raised from the floor
No additional issues were raised from the floor.

9. Section Visitor Comments – Michael Dorff

Section Visitor Michael Dorff, Past-President of MAA, praised the Section and its leadership for the level of organization. Visitor Dorff encouraged nominations for MAA Awards, particularly the new Inclusion Award, and enrollment and use of MAA Connect. Visitor Dorff thanked the Section for the invitation to visit.

10. Adjournment

Motion to adjourn was made and seconded. The meeting adjourned at 10:25 am.
