I apologize for my slowness in responding to your request. The nominating committee last year was Charles Brase (who is no longer on because he was the chair and that is an outgoing job), Freida Holley (Metropolitan State) and Cliff Britton (Mesa). Thus, Freida and Cliff need a colleague. My memory is that Freida has been on for two years and so becomes Chair. Cliff would then be chair next year. I know that Bill Emerson has been on the committee recently.

This year the committee will have to nominate a chair-elect and a vice-chair (who is from the 2-year colleges).

I am excited to hear that both Pomerance and Siegel will be at the 1995 section meeting. They should help you and your colleagues at USC make this year's meeting one of our best.

For planning purposes, we might wish to submit a request for a grant from the aid to sections. I am sending you a copy of this letter, and xeroxing the appropriate material from the MAA.

The highlights are: The request cannot exceed \$500/yr. "High priority will be given to Section sponsored projects which will improve Section meetings, projects which are of direct professional benefit to all mathematical scientists within the Section, and projects which encourage diversity in attendance and enhance student participation in Section meetings.

Application deadline is Dec 1 (there was also a July 1 deadline for academic year funds.)

Tino's motion on the CCTM/NCTM member of our committee should not get lost. Have you or he an idea for implementation? Have you or Tino any ideas for establishing contact. I know this year the state CCHE/CDE have worked on this statewide and of course both you and Tino have had successful local meetings.

You idea of carrying-over nominations for Distinguished Teacher is a good one. I would suggest that when the annual request for nominations goes out, that we ask nominees if they wish to keep their nominations active. I do think that additional material can be added. However, since nominees cannot nominate themselves, perhaps we could ask the original nominator to submit an update. I am fairly certain that nominees could funnel material through the nominator. If the original nominator declines to add new material, we would just go with the original file. If the original nominator has moved, the appropriate department chair could be asked for further information.

It has been suggested that the awards for Distinguished Teaching and/or service be given at the evening dinner. Comments.

It has been suggested that the Executive Committee meeting be at noon on Friday, rather than at Sat breakfast. There are some obvious advantages/disadvantages. The breakfast time is short and quite hurried. It is hard to prepare any motion or real additions to the agenda at a time so close to the business meeting. On the other hand, it is good to have the section speakers visit the executive meeting (Siegel in this case) and they are not in town Fri. Also, the program chairs are busy Fri noon. Further they are not able to give us meeting information.

If we did meet on Fri, I would suggest 11:30, or even 11. It would be OK with me either way.
