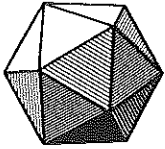

Dear Professor Ramaley:

Enclosed is a check for \$700.00, the annual MAA subvention to the Rocky Mountain Section for 1999. We are pleased to support Section activities in this way.

Subventions are calculated on the basis of \$200 plus 2.24% of the total individual and institutional dues paid by members in the Section in calendar year 1998. The payment is rounded to the nearest \$100 with minimum payment of \$500. This formula was adopted in 1996 by the Finance Committee as the standard procedure for annual subvention payments. The formula's development was guided by the desire for simplicity and fairness to all 29 Sections.

The dues paid by individual and institutional members in the Rocky Mountain Section for 1998 totaled \$20,592.00.
